## The Extraordinary Chambers in the Courts of Cambodia

The Extraordinary Chambers in the Courts of Cambodia (ECCC) were established under an agreement between the Royal Government of Cambodia and the United Nations.

With the support of the international community, the ECCC investigated crimes that occurred between 17 April 1975 and 6 January 1979 and assisted the people of Cambodia in their pursuit of justice, national reconciliation, and peace.

# How to navigate the digital Archive?



## Quick Search

A shortcut to listings such as *Recent filings*, *Case 001*, *Case 002*, *Trial videos*, etc., without additional refinement.



## Search Bar

Press “Enter” while your cursor is in the search bar, or click the **blue search icon**. This will take you to the *All Filings* results page.

## Homepage

A link to the main ECCC website — this button is available throughout the archive interface.

## Language options

Option to choose between **ENGLISH**, **KHMER**, and **FRENCH**.

## Footer Menu

Access to additional information.

- **What is Archive:** A brief explanation of the ECCC Archive.
- **How to Search:** A video tutorial on how to use the digital archive.
- **How to Read Judicial Documents:** A PDF Guide explaining judicial documents, symbols, and related information (this appears across the search/results pages).
- **Public or Confidential:** A brief explanation of how information is classified at the ECCC.
- **My session:** A quick access to your archive account.

## 1 Archive portal

There are two types of document portals in the ECCC Digital Archive — **Judicial** and **Non-Judicial**. Use the toggle to switch between them.

- **Judicial:** The ECCC judicial archive.
- **Non-Judicial:** Public Affairs Section materials and other documents produced outside the Chambers.

## 2 Search Filter

This functionality allows you to filter the search options — *Cases*, *Languages*, *Record Types*, *Filing Party*, and *Document Date* — to refine your results. It will lead to a similar outcome as the **Quick Search** on the homepage.

Tips: Explore the Record Type to discover interesting documents among our collections.

## Search Bar

Type any keyword or document number to start the search.

## Display feature

- **Sort** by most recent or least recent date (filing date).
- **Result:** Determine your preference length of document display per page.
- **Columns:** Option to expand your views for convenience.

Tips: Within your search results list, you can use the display options under each column to help identify language types or cases. It works similarly to the filters on the left.

- **Saved:** Access your list of saved documents.
- **History:** View your previously opened documents. Your web browser's cookies will store this history for six months.
